<u>Referees & Judges</u>: All officials MUST be approved by the MTA and have appropriate registration. I am aware I must confirm with my state body the costs of officials and pay them directly at the event. I am aware that any National Titles require approved officials and may incur extra expenses.

This form must be filled out and sent to MTA state representative NLT 28 days prior to the event. Fees for sanctioning are as follows and are to be paid on application. This form is to be sent to your state MTA representative for processing. States must then forward a copy to the General Secretary.

The dates of any MTA shows must be approved by the state board. Any expenses occurred prior to approval, if declined, are at promoters expense. Titles are not to be advertised until approved.

Sanction fee -These can be set by each state based on their requirements and CSA requirements. Sanctioning fees are payable to the state sanctioning the event. If the state is NOT a registered association affiliated with the MTA, the fees are payable directly to the MTA national body. National title sanctioning is payable to the MTA. All belts are to be ordered through the MTA Financial Director.

All promoters will be invoiced by the relevant state body/national body as required.

•	The promoter gives approval for the MTA to advertise the event.
•	The MTA has the authority to decline a Promoters request for sanctioning. The MTA has the authority to decline a fighter or club from being matched on an MTA show. The MTA/IFMA/WMC logo is to be used on all Pro and Pro-am shows. All development days are to advertise the MTA and state MTA logo.

#### **Sanctioning Fee Scale:**

Incorporated states can set their own sanctioning fees.

## National Body Fee's.

National Professional Australian Title - \$0 plus Title Belt.

**Officials.** The MTA head R&J, must approve the officials for any professional Australian Title. The referee and one judge must be either interstate/deemed qualified and experienced by head MTA R&J. Expenses will be determined on a case by case basis. Payable to the MTA.

**International Title:** To be applied for via the MTA Executive. Costs will be quoted per event.

### **Sanctioning Fees for Events.**

- **Professional Show or Pro/Am- \$250** (charging entry fee for a public advertised show with professional, A-class fighters on.) 2 or more Pro (A-class bouts). \$350 for non MTA Club.
- Amateur show \$150 (charging entry fee for a public advertised show with Amateur (B-class) fighters on. (Max of 1 Pro (A-class bout).
- Club show/development day \$125 (in a member's own club and low budget. Not more than 1 A-class bout on the card. Featuring C-class bouts, novices, development day type event.
- **Kids show \$100** (a show featuring kids, in a club or hired venue no more than 1 adult fights as features or it is an Adult show for purposes of fee's)
- Tournament Style MTA/IFMA show but promoter conducted. Sanctioning fee above, and when entry fee collection exceeds sanctioning fee plus \$5 an entrant. (Kids show is \$100 which includes first 20 entrants then an additional \$5 per entrant)
- **State titles** State pays MTA sanctioning fee as per above. Rest of the money to the state after expenses. Expenses can include an event manager.
